WHAT ARE MATCHING GIFTS?

Matching Gifts are gifts in which companies financially match donations that their employees make to nonprofit organizations. Most companies match at a 1:1 ratio, but some have a higher match ratio.

Disney's Matching Gift Submission Process:
Employees register their donations online and then email the matching gift certificate to the nonprofit. The certificate includes a "Gift ID" which the nonprofit uses to claim the matching funds.

Once CHOC receives proof of the matching gift donation from the donor's company, we will apply a credit to your account, which will reflect in your total fundraised amount. CHOC does not need to physically receive the funds in order to get the credit. The company confirmation is their promise that the funds are coming.
